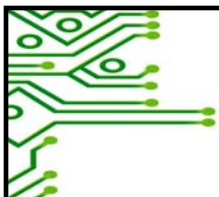

CANCELLATION POLICY: Due to considerable administrative costs incurred in registration processing, a fee equivalent to 20% of the registration fee will be charged for any cancellations received prior to the 7th August 2010. Cancellations after 7th August to Friday 27th August will be subject to a 50% cancellation fee, representing costs charged by the venue for confirmed numbers. From Friday 27th August @ 5pm cancellations will incur a 100% cancellation fee. Delegate substitutions are a welcome alternative and in this instance no fees will be charged. All requests for cancellations or substitutions **MUST** be made in writing to the Society and will be honoured only if they have been confirmed in writing by the Society.
